## 6 Presentation of the Annual Report

Richard highlighted the following area of activities:

- Pathway of Faith project. Looking at how we can continue to Worship, Grow, Live and Share within a multi-generational community.
- The ongoing Seismic Strengthening of the Church with its disruption to our community but building on the faith of our forefathers. Throughout all the disruption the Ministry team and the Administration Team have continued to work on our behalf.

7 Presentation of Financial Reports, Seismic Strengthening Fundraising and Proposed Budget Ross Chesney, Treasurer, spoke about these as follows:

## a) Financial Reports

• The financial performance for the year resulted in an operating surplus of \$31,126 and deficit after transfers to reserves of \$72,256. This is significantly less than the 2017/18 deficit of \$308,525. Costs have been kept down wherever possible. Property is a big ongoing cost. Currently maintenance is being done on a 'fix only' requirement and long term maintenance such as upgrading the St John's Centre, (now 25 years old) has been deferred.

## b) <u>Earthquake Strengthening Fundraising Update</u>

Fundraising to 30 September 2019 amounts to \$3,060,935, which represents 73% of the target of \$4,200,000. This includes congregational giving, legacies, fundraising and external money received including Lottery Environment and Heritage grant, Wellington City Council grant and contributions from former members.

However, total costs have now risen to \$5,500,000 due in part to discovered maintenance such as borer damage and rot.

Funding for these additional costs will come from the Trust Fund Capital. This is allowed by the Church Property Trustees whose Property Handbook states that "Capital Funds may be used for major renovations and alterations (including earthquake strengthening)".

The contractors, LT McGuinness Limited, are currently on time and budget.

## c) 2020 Budget

(i) The way ahead will be difficult. The current economic conditions means the real return on savings is about 1%. Very low interest rates are the new normal and there is now a possibility of negative net interest.

The overall budget deficit is \$460,000. This is caused mainly by:

- Decreasing Trust Fund income driven by very low interest rates.
- Use of capital from the Trust Fund to pay for earthquake strengthening which will reduce subsequent income.
- Increasing expenses including property costs, insurance, professional costs, staff and youth activities, over which we have only limited control.
- (ii) Budget actions to address this position include:
  - Increase yield from the Trust Fund by:
    - investing in Church Property Trustee new long term fund, which will be a more diversified fund, with better return but also some increased risks and volatility.
    - review all possible wider investment options.
  - (2) Continue fundraising for earthquake strengthening and this will reduce impact on Trust Fund and subsequent income.
  - (3) Establishment by Session of a Review Group with wide ranging Terms of Reference. The overall aim is to:
    - reduce the budget deficit by \$150,000 in the 2019/20 financial year
    - bring St John's to a long term sustainable financial position by June 2021.

It was moved that the 2019/2020 Budget be approved.
